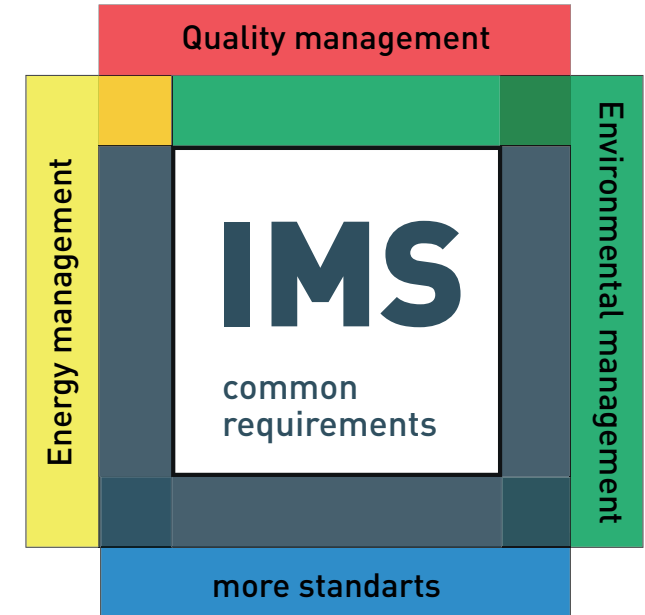

VERSION CONTROL

When a document was changed, version control will automatically track this change.

FOLDER STRUCTURE

The Steinbeis IMS can use the existing folder structure of the company. The folder structure including all data and documents is automatically indexed during installation.

DATE STAMP

Documents receive a current date stamp when opened.

ACCESS CONTROL

Define which documents or information can be created, changed or read by different users.
